Government Of India, Ministry Of Railways ,Railway Recruitment Board you appointment as Assistant Divisional Committee For Level-1,2,3,5,6 Candidates Under CEN No. 01/2019 (Probationer) in the Indian Railway based on the recommendations made by the Union Commission on the basis of results of the RRB NTPC Examination 2022.

2. You are directed to report to the Director General, National Academy of Indian Railways, Multi-Disciplinary Divisional Training Institute, hhp Western Railway Virtually Inaugurated **Multi-Disciplinary Divisional Training Institute (MDDTI) at Valsad (MUMBAI)** on 25.12.2023 to 10.01.2024 for joining formalities and probationary training. You will be provided with single accommodation at Western Railway (MUMBAI).

3. The terms and conditions of service, which will be applicable to you, as well as Bond Proforma and Declaration Form, may be downloaded from Indian Railway's official website at the following link:

Your specific attention is invited to Paras 2, 3, 4, 9 and 10 of the Terms & Conditions. Formats of undertaking referred to in Para 3 to be signed on a Rs. 100/- Stamp Paper, and the Declaration referred to in the Para 9 of the Terms & Conditions are to be submitted to the Director General, National Academy of Indian Railways, Western Railway (MUMBAI) at the time of reporting for training, failing which you shall not be permitted to join.

4. Your continuance in Railway service shall be subject to your character and antecedents being found satisfactory by Police/District Authorities.

5. You are required to submit your original Rotatory Internship Certificate to the Director General, National Academy of Indian Railways, Western Railway (MUMBAI) at the time of reporting for training. In the event of your failure to produce Internship Certificate at the time of reporting to the National Academy of Indian Railways clearly indicating that you have completed one year's internship, you shall not be allowed to join Railway Service. In addition, you are also required to produce all the original certificates while reporting at the Training Institute.

6. If you claim to belong to SC or ST or OBC or EWS category, you may please note that "the appointment is provisional and is subject to the caste/tribe certificate being verified through the proper channels and if the verification reveals that the claim to belong to SC or ST or EWS or OBC or not to belong to creamy layer of OBC, as the case may be, is false, your services shall be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates".

7. If you are already serving in any Organization, you must produce No Objection Certificate from the employer under whom you are serving.

8. In case, at any stage, it is found that any certificate/ document/ testimonial, etc. furnished by you and having a bearing on your eligibility is not in order or any information/material facts having bearing on your eligibility has been hidden/ misrepresented by you, then your appointment is liable to be cancelled forthwith without prejudice to any other punitive action under relevant rules.

9 Please inform this Office as well as Director General, National Academy of Indian Railways, Western Railway (MUMBAI) through online mode within a week as per the Format-I attached with this letter whether you accept this offer of appointment. If you accept this offer of appointment, you should report to Director General, National Academy of Indian Railways, hhp Western Railway Virtually Inaugurated **Multi-Disciplinary Divisional Training Institute (MDDTI) at Valsad (MUMBAI)** on 25.12.2023 to 10.01.2024 for joining formalities and probationary training.

10 If you fail to join on the stipulated date, the offer of appointment is liable to be cancelled. On your joining at National Academy of Indian Railways, Western Railway (MUMBAI), you will not be granted any kind of long leave before completing the training. Only justified cases supported with documentary proof will be considered for grant of extension in joining time which will be subject to do P&T's OM No. 35015/2/93-Estt(D) dated 09.08.1995 and the same will not be granted as a matter of right. In your own interest you should pursue your request for extension in joining time. Non-receipt of letter granting extension in joining time or non-receipt of any type of communication from Ministry of Railways in this regard, etc. will not be considered as a reason for not joining and subsequently requesting for revival of offer. In terms of do P&T's OM No. 35015/2/93-Estt(D) dated 05.01.2024, the offer of appointment lapses after expiry of six months from the date of offer of appointment. (in this case offer would lapse automatically on 17.05.2024).

11. This appointment carries with it the liability to serve anywhere in India and you are liable to be posted/transferred to any part of India as per administrative requirements. Zonal Railway/Production Unit allocation will be made by the Government according to the Zonal Allocation Policy given at the link:



candidates should be allowed to join only on satisfying yourself that he/she has completed one year's (365 days) internship. Original internship certificate should invariably be verified and a photocopy thereof duly attested by National Academy of Indian Railways should be forwarded to this Ministry within 15 days of the date of joining of the candidate. Your attention is also invited to Para 6, 7 & 8 of the offer of appointment addressed to the candidate.

(iii) The candidates allotted for training are required to execute a bond in the prescribed form. The same may be obtained from him/her as soon as he/she joins and kept in the personal file of the candidate.

(iv) The caste certificates produced by the candidates claiming to belong to SC or ST or EWS or OBC or not to belong to creamy layer of OBC are required to be verified. In case of false declaration being furnished by the candidates, appropriate action should be immediately initiated against them as per extant instructions.

(v) There are sixteen (16) candidates with "Conditional" candidature, recommended by UPSC on the basis of CMSE-2021. All the requisite certificates along with other documents of these candidates may be verified by SWR before allowing them to join.

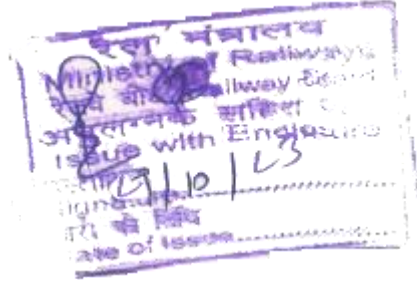
